AGREEMENT FOR ACADEMIC EXCHANGE AND COOPERATION

between

BAR-ILAN UNIVERSITY

and

SAN PABLO-CEU UNIVERSITY

Taking note of the mutual desire to establish a relationship of profitable collaboration in the areas of reciprocal interest, Bar-Ilan University of Ramat Gan and San Pablo-CEU of Madrid (hereinafter referred to together as the two Universities) undertake in their reciprocal relationships and in the spirit of friendship which enlivens the relationship between the two countries, to underwrite the following:

SCIENTIFIC AND CULTURAL COLLABORATION AGREEMENT

Article 1

The Contracting parties will prepare articulated program of collaboration between the scientific research sectors common to the two Universities.

Article 2

The collaboration will principally be articulated as follows:

- A) The two Universities will agree on the exchange, on the basis of reciprocity, of university-teachers, researchers, graduate and undergraduate students for study stays, research and conferences. The two Universities will encourage the exchange of scientific experience, according to programs jointly agreed on by the legal representatives of the two Universities.

- B) The two Universities will exchange information as regards international participation at congresses, symposia and seminars organized by each University. When necessary, the two Universities will organize congresses, symposia and meetings together. The two Institutions will commit themselves to the exchange of all publications related to the initiatives hereto mentioned.
- C) The two Universities will encourage the development of cultural and sporting links between respective student members.
- D) The two Universities will endeavour to increase the collaboration between the two university libraries and to promote contracts with other cultural institutions in the respective countries.

Article 3

In order to effect the provisions of this agreement, the contracting parties will draw up programs valid for one year relevant to the interested Faculties, Departments, Institutes or individual members of teaching staff involved. The programs will specify the form and total financial cost of collaboration as and when drawn up.

Article 4

Costs for the exchange of University-teachers, researchers, graduate and undergraduate students, as laid down in Article 2 of this agreement, will be met on a basis of reciprocity. In particular each University will bear the costs of travel for its own members.

Article 5

Bar-Ilan University and the San Pablo-CEU University will make a joint effort to establish a fund, the fruit of which will be used for the implementation of this agreement.

Article 6

This agreement will take effect with the signatures of the Rectors of the two institutions. The duration of this framework agreement will be for a year and it will be automatically renewed. It can be shortened by mutual consent, except in the case of litigation by either of the parties, and may be terminated, by prior agreement between the two parties or by the express notification of either one of them, in writing and with prior warning of 120 days, without prejudice to the joint projects that may be pending conclusion.
