Memorandum of Cooperation

between

Department of Psychology BAR-ILAN UNIVERSITY

represented by Prof. Meni Koslowski, chairman

Palacký University, Olomouc, and the Department of psychology, Bar-Ilan University hereby agree to establish and support cooperative relationship, which will emphasise the development of joint educational and research projects. Both institutions will encourage direct contacts and cooperation between the members of their academic community, departments, institutes and research centres subject to the provisions of this Memorandum.

Article 1

Within the fields of study which will be mutually designated, Palacký University, Olomouc, and the Department of psychology, Bar-Ilan University agree to the following general forms of cooperation:

- 1. Exchange of teachers and researchers;
- 2. Exchange of graduate and doctoral students;
- 3. Exchange of administrative and professional staff;
- 4. Joint sponsorship of courses, study tours, conferences and seminars;
- 5. Joint research projects including projects eligible for governmental and other grants;
- 6. Exchanges in the field of sports and arts.

Other areas of collaboration and cooperative projects related to them may be identified and developed in future. Prior approval of both universities is required for the initiation of any project developed under the terms of this Memorandum.

Article 2

The terms of joint activities, conditions for utilising the results achieved, and arrangements for specific visits, exchanges and other forms of cooperation will be negotiated for each specific activity. It is also understood that any financial arrangements will be negotiated and agreed in writing for each specific case and will depend upon the availability of funds.

Article 3

At the Department of psychology, Bar-Ilan University all the activities performed under the Memorandum will be coordinated by the prof. Meni Koslowski, at Palacký University, Olomouc, by the International Relations Office.

Article 4

The Memorandum will become valid and effective upon the date of signature by the representatives of both universities.

Article 5

The official representative of either institution may terminate the Memorandum by a written notice at least six months before the termination becomes effective, and the time notice becomes valid from the date of the notice delivery to the other side. Such a termination shall not affect the rights of anybody who participated in the activities under this Memorandum prior to the receipt of such notice.

Article 6

The Memorandum is signed in four original copies, two in Czech and two in English. Both versions are of equal validity.

Article 7

It is understood that this Memorandum of cooperation does not confer any legal rights or obligations on either party. Both institutions subscribe to the policy of equal employment opportunity and not discriminating any person on the basis of race, colour, religion, sex, sexual orientation, age, national origin, marital or veteran status, and physical or mental handicap. Palacký University, Olomouc, and the Department of psychology, Bar-Ilan University shall abide by these principles in the administration of this Memorandum and neither institution shall impose criteria for the exchange of teachers, scholars or students which would violate the principles of non-discrimination.
